

Illinois Solar for All Approved Vendors create lease or Power Purchase Agreement to "own" system and monetize credits and incentives







Two Primary Issues

Not enough Approved Vendors.

The residential subprogram only has two companies (i.e. Approved Vendors) currently offering Illinois Solar for All. Lacks statewide presence. Lacks opportunities for small and emerging businesses.

Not enough qualifying customers.

Finding a customer that meets all of the criteria and owns a home ready for rooftop solar is a challenge.






COMPREHENSIVE APPROACH
